AFFIDAVIT

BEFORE ME, the undersigned authority, a Notary Public, duly commissioned and qualified in accordance with law, in and for the above referenced Parish and State, personally came and appeared representing Affiant's self or the following legal entity _____

who, having first been duly sworn, stated under oath that:

1. Affiant has legal title or legal authority and capacity to act on behalf of the Permittee with regard to the property located at _____.
2. Affiant has read Ordinance No. 22-64, fully understands its terms, conditions, and obligations, and agrees that Affiant and Permittee will abide by the same.
3. Affiant understands and acknowledges that the temporary recreational vehicle (R/V) permit shall not exceed the term (time frame) provided for by the temporary R/V permit.
4. Affiant understands and agrees that an annual fee of one hundred dollars (\$100.00) per R/V site/space is due and payable to Plaquemines Parish Government at the time of application and before the annual anniversary date of the issuance of the temporary R/V permit.
5. Affiant acknowledges and agrees that no recreational vehicle shall occupy the same R/V site/space for a period exceeding one hundred and eighty (180) consecutive days. Affiant understands and agrees that the Permittee is responsible for filling out the Temporary R/V Permit Reporting Form and submitting it every hundred and eighty (180) days to the Permits, Planning, and Zoning Department. Failure to comply with this paragraph may result in the forfeiture of the Permittee's temporary R/V permit.
6. Affiant acknowledges and agrees that any accessory buildings on the site shall remain portable and shall be moved in the event of a hurricane and/or at the expiration of the temporary RV Ordinance No. 22-64.
7. Affiant understands and agrees that Permittee must obtain and maintain a valid Occupational License during the term of the temporary R/V permit.

8. Affiant understands and agrees that the temporary R/V permit confers no legal rights or alters in any way the legal rights, obligations, or restrictions to the Permittee's property vis-a- vis third parties, nor shall the temporary R/V permit confer any permanent rights to R/V site(s) or park(s) on the Permittee's property.
9. Affiant understands and agrees this permit shall not be assigned to other persons or entities without the approval of Plaquemines Parish Government.
10. Affiant and Permittee understands and agrees to be bound by the penalties established by Ordinance No. 22-64 which reads as follows:

“Subsection 12. Violations and Penalty.

- A. It shall be unlawful for any person to construct, install, enlarge, alter, maintain, operate or convert any recreational vehicle park or site or to use or allow the use of any land for same, or to lease, lend or authorize the placement of recreational vehicles on land, or to cause the same to be done, unless a valid temporary permit has been issued by the Department.
- B. Any person, firm or corporation violating any provision of this Ordinance shall be fined not less than two hundred fifty dollars (\$250.00) or more than five hundred dollars (\$500.00) or sentenced to imprisonment in the Parish jail for a period not to exceed thirty (30) days or both. Each day that a violation of any provision of this Ordinance shall occur or continue to occur shall be deemed a separate and cumulative offense.
- C. Plaquemines Parish Government may suspend, revoke, or rescind any temporary permit or deny the application of any future temporary permit authorized by this Ordinance for fraud, misrepresentation, or violations of this Ordinance.”
